**Performer Statements of Obligations**

I understand and acknowledge that my participation as a member of the Fremont Opera House Middle School Summer Arts Camp is a privilege. This brings significant obligations. I understand that I must attend all rehearsals June 1-5, 2026 from 10:00am to 5:00pm each day and the camp performances on Friday, June 5, 2026 at 3:00pm and 5:00pm.

**Performer Code of Conduct Contract**

1. Each individual is responsible for his/her own personal possessions. Fremont Opera House will not be responsible for lost or stolen items. Bring valuables at your own risk.
2. Cell phones and other electronic devices may be brought to camp but will be left at a designated table and turned off during rehearsal times.
3. Performers must be reasonably quiet during rehearsals unless otherwise requested by the directors.
4. Possession or use of tobacco, alcohol, or other controlled substances will not be tolerated. Local authorities will be contacted. Your parents will be contacted and you will be asked to return home.
5. Students requiring prescribed medication must note this on the medical release form and give the medication to the directors during camp hours.
6. Prompt attendance at all rehearsals and the performances is mandatory. Students who are tardy or fail to attend will be dismissed from the camp. If students are wearing inappropriate clothing (i.e. too revealing, alcohol or drug related, etc.) the parents will be called to bring a change of clothing.
7. Students will be expected to be on their best behavior at all times.
8. Leaving during the rehearsal day is not allowed. This will result in performer's immediate dismissal from the camp. Parents will be called.
